

Year End Giving Announcement:


Just a friendly reminder, as we begin a new year,

- If you are mailing 2025 contributions, they must be postmarked by December 31, 2025. Anything postmarked with a 2026 date, must be recorded as a 2026 donation.
- If you are dropping off 2025 contributions, they must be received in the office before 3:00 pm on Wednesday, December 31, 2025.
- Electronic donations must be received by the church account on or before December 31, 2025.
- Scrip profit donations will be recognized on scrip purchased on or before December 31, 2025.
- If you are pre-paying your 2026 pledge in 2025, you must indicate this in a note with your donation so we may update your pledge status accordingly. Please be sure to have your donation postmarked by December 31, 2025.
- If we receive a donation by Dec. 31, 2025 or postmarked in 2025, even if it is donated in a 2026 offering envelope, it will be recorded in 2025.

The following will be reported as 2026 donations:

- Any donations postmarked after December 31, 2025 (even if donated in a 2025 envelope or with a check dated in 2025).
- Any donations received by the office, other than by mail, after 3:00 pm on Dec. 31, 2025 (even if donated in a 2025 envelope or with a check dated in 2025).
- Scrip profit donations for scrip purchased on or after January 1, 2026.
- All electronic donations deposited into the church account in 2026.

Unfortunately, the on-site meeting that had been scheduled for November 29th did not take place. The candidate that we were working with was already farther along in the process with a different church and has accepted a call from them instead. It was unfortunate timing.

Whew! December was a busy month at St. Paul's. There was a lot of decorating, preparing the float for the Wausau Holiday Parade, the Children's Christmas program, more decorating, the Living River concert, Salvation Army bell ringing, more decorating, Breakfast with Santa, the Elf Shop, a Festive Sweater contest, the Christmas Day community dinner, more decorating, Advent Sunday services, Christmas Eve services, and... more decorating.

If we were to thank each person who played a part in making it all happen, half the church directory would be included here. For brevity's sake, we'll highlight the contributions of a handful of folks who helped out in December: Jim and Joan Mielke for lending their trailer for the church's parade float; Gerry Brummond, for use of his gas generator and for maintaining the church van; Confirmation students and parents for braving the cold and handing out flyers at the Holiday Parade; the Ladies of St. Paul's for organizing the Elf Shop; the Helke family for organizing and cooking for Breakfast with Santa; the Mission Committee and volunteers, both from St. Paul's and outside the church, who served the Christmas Day dinner; all the ushers and musicians who contributed their time and talents to our Advent and Christmas services; and, last but not least, to all our decorators. Thanks to all of you!

Who was Lewis H. Hall?



If you've ever had to open the Choir Room door, you've bumped into this plaque on the door. In case you can't make out the text, it reads, "The Choir Room Furnishings in loving memory of **Lewis H. Hall**." Fumbling for the keys in my pocket, I often thought, "Who was Lewis H. Hall?"

According to his obituary posted on a genealogy page, Lewis Harmon Hall was a pioneer in many ways. He was born in 1881 outside of Marathon City to a farming family, and after his school days were over, Lewis briefly worked as a farmer, blacksmith, and carpenter. His entrepreneurial career took off after he moved to Wausau in 1904. While managing his own bicycle shop on 3rd Avenue, Lewis and a partner brought the first load of automobiles to Wausau in 1906.

A few years later, he joined Fred Schubring in establishing the Schubring Motor Car Company. In 1911, Lewis and some partners constructed a prototype automobile they called the "Wausau Flyer" (see picture below). While the vehicle never went into production, Lewis deepened his connections to the growing automobile industry,

becoming a dealer for Packard, Velie, and Maxwell cars, as well as building his own garage. Later, he would establish the Hall Oil Company, dealing in gas, motor oils, kerosene, and lubricants. In addition to his business interests, Lewis was also a pioneer in aviation, in 1928 flying a ski-equipped plane from Wausau to Rhinelander in a then-record 42 minutes.

Who was Lewis H. Hall? I suppose you could say he was early 20th-century Wausau's version of Mark Cuban, a man who embraced the technological and social changes of his time and carved out a name for himself in the growing Wausau business community. And after he died in 1961, his heirs donated the money to outfit the Choir Room in the new St. Paul's church. His obituary fails to note whether he sang tenor or bass.
