- 1. For each fuel oil delivery I may pay the amount shown on my delivery slip minus one ten (10) cent per gallon discount (auto fuel delivery only) if payment is received by the discount date shown on the delivery slip providing no previous balance exists.
- 2. I may
- a. Pay the Balance Due in full within 15 days from receipt of my monthly statement.
- b. Elect to set up a formal budget plan for monthly payments as set forth in any *Approved Budget Agreement* or any amount in excess of the stated amount. I understand that a payment is required each month under the *Approved Budget Agreement*.
- I agree that a default in the payment of amounts due for service or fuel deliveries, or of any agreed upon monthly installment, shall render the entire balance due and payable and that Stocker Oil Company reserves the right to alter the terms of payment, determine my right to make further purchases, to fix a Limit of Credit, and if there is a credit card on file, the outstanding balance will be charged to the credit card.

 - c. The dollar amount of the suspected error.

Within 90 days we will mail a written notice stating that the amount believed to be in error has been corrected or send a written notice setting forth the reasons why we believe the account was correctly shown in the statement.
