Offer not available at eCommerce or retail businesses, except Kohler certified dealers participating in Home Depot or Lowe's retail installation programs. Kohler resellers are not eligible for this offer. Offer may not be combined with other offers or promotions. Generators registered by a non-certified Kohler partner or the homeowner are not eligible for extended warranties. Generators used in an off-grid/prime power application are not eligible for extended warranties.

Step 1: COMPLETE SUBMISSION FORM + PROOF OF ORDER



Certified Kohler partner must complete the online [submission form](#) with consumer information, serial number**, and valid consumer proof of order by [June 15, 2026](#) to qualify.

**Online [submission form](#) must be completed by [June 15, 2026](#) regardless if generator is installed/registered or not by this time. Serial number is not required on this form if still pending install but must then be emailed to Service@KohlerRebates.com by the installation deadline, [September 30, 2026](#), to qualify. Reminder emails will be sent to certified partners who have submissions pending serial numbers through September 30, 2026.

†Examples of a valid proof of order include a consumer down payment receipt, signed consumer quote, consumer order confirmation, etc. This document must:

- 1) Be dated between April 1 - May 15, 2026
- 2) Be addressed to the consumer
- 3) Include a qualifying* KOHLER generator

Step 2: INSTALL & REGISTER

Certified Kohler partner must install and register the generator serial number in [Rehiko Power Assistant \(RPA\) Warranty System](#) by [September 30, 2026](#) to qualify.

Please add homeowner email to registration in RPA to ensure homeowner will be notified when extended warranty is applied.

Generators registered outside of Rehiko Power Assistant and/or by the homeowner are not eligible for extended warranties.

Kohler Applies Free 10-Yr Extended Warranty

Please allow two to five weeks for review of submission form and proof of order (completed with serial number). Once approved, please allow an additional two to three weeks for [Kohler to apply the free 10-year extended warranty](#) to the registered generator serial number.

Certified Kohler partners should not purchase the generator 10-year extended warranty. Kohler will not issue credits to partners that incorrectly purchase extended warranties.
