What's included:

- Monthly battery charge (lead acid)
- Tire pressure check (inflation to sidewall rating)
- Water levels checked and maintained.
- Monthly maintenance will not occur on gas carts.
- Courtesy cleaning prior to delivery.
- All electric carts will be delivered back with a full charge on battery.

Storage Requirements:

We visually inspect and take photos of any damage such as broken mirrors, rips and stains in seats, broken lights, dry rotting, under-inflated and flat tires, scratches, dents and other mechanical and cosmetic issues.

- **Gas carts** should have a full tank of fuel with fuel treatment added prior to pick up or delivery into storage; if not completed on arrival to service shop you will be charged for parts and labor of cart service prior to property being stored.
- **Electric carts** should have **full charge prior to pick up or delivery into storage**. If not at full charge at arrival into storage an additional service fee of \$35.00 will be charged to account.
- Please **remove** all loose objects and personal property prior to storage.
- **Remove** storage covers prior to transport (if you would like us to store cart with cover on please verify that at time of reservation).
- Flip down windshields should be flipped down and secured during transport.
- **Charge batteries and check water level at least one day before your cart goes into storage.**

- Enclosures should be **removed** prior to transport – if this is not done Kappy's Karts is not liable to any damage done during transport.

TERMS AND CONDITIONS OF STORAGE

Kappy's Karts and Owner, for good and valuable consideration, each intending to be legally bound, agree as follows:

1. Owner Shall be bound by the "Terms and Conditions of Storage" attached to and made a part hereof this agreement.
2. Golf carts must be fully operational. Unless repaired, non-operational golf carts are **not eligible** for storage.
3. This agreement is valid for gasoline and electric powered golf carts.
4. Kappy's Karts reserves the right to refuse storage if any of these conditions are not met.
5. Kappy's Karts grants Owner permission to store golf cart or other property agreed upon in agreement, collectively called the "stored property".
6. **No stored property shall be stored our facility without a signed agreement.**
7. Monthly charge of \$ _____ will be set up as an automatic payment every month on the date of pick up for storage _____. (Credit Card Authorization form is attached and must be completed and returned) 8. Owner MUST submit completed agreement within 15 days of pickup date.
9. Failure to submit completed agreement within 15 days will result in stored property being removed from facility and extra fee of \$50.00 for delivery.
10. **Minimum of 5-day notice shall be given prior to return of stored property.**
11. All balances due on account will be paid prior to delivery of stored property.
12. After 24 months, all monies due to Kappy's Karts for failure to pay and/or communicate status of return on stored property will become Kappy's Karts property.
13. Each cart must have **own key and charger** at arrival of storage. *A fee will apply if cart is delivered to storage without a charger at a rate of **\$15.00 monthly service fee on top of the monthly storage fee and a key charge of \$7.00.***
14. Electric golf carts shall be stored with owners' fully functioning battery charger.
15. **ALL** loose and personal items shall be removed prior to pick up. Kappy's Karts shall not be liable for any loss, damage or fines suffered by or to the stored property or other persons or property resulting from any condition, act or occurrence of whatsoever nature.

16. Storage does not guarantee any condition of any golf carts. Weak batteries may fail during storage regardless of storage option. Kappy's Karts is not liable for failed batteries, we have no control over condition of batteries prior to storage at our facility or inoperable conditions.
17. Stored property shall be assessed by Kappy's Kart service location prior to storage.
18. Owner is prohibited from assigning Owners' rights under this Agreement to any other person or entity.
19. Kappy's Karts discloses to Owner that it does not carry insurance of any type or kind for the benefit of the Owner. Kappy's Karts assumes no liability for loss or damage to stored property during the term of this Agreement.
20. Kappy's Karts discloses to Owner that it does not provide security services for the benefit of the Owner.
21. Kappy's Karts discloses to Owner that it does not guarantee conditions inside storage facility.
22. This Agreement contains all the Terms and Conditions of the Agreement between Kappy's Karts and Owner. No modification of this Agreement shall be binding up on either party unless such modification is made, in writing, and signed by both Kappy's Karts and Owner.
23. Kappy's Karts reserves the right to refuse a service based on golf cart condition and/or accessories installed.
