- F. **Reports/Discussion Items**
 - a. **February 2026 Financial Report - Andrea Amburn** - Ms. Amburn reviewed the February 2026 financials with the board. The school has \$2,254,683.14 in operating cash, providing 125 days of cash on hand. The projected year end net loss is -\$670,967.11 due to the addition of middle school and revenue cuts to virtual schools.
 - b. **FY27 DRAFT Budget - First Reading - Andrea Amburn** - Ms. Amburn gave a detailed overview of the FY27 budget. Currently OOL has an enrollment of 650 and anticipates the 135th day count increasing. The school would like to increase its enrollment for the 2026-27 school year to an ADM of 756. Ms. Amburn reviewed enrollment goals, an increase in staffing, and revenue and



expense changes. The projected net loss for the FY26 budget is negative \$670,967.10. The projected FY26 fund balance is \$1,726,141.41.
