

## **Parent and Family Engagement Policy**

Odyssey Online Learning receives Title I, Part A funds and therefore must develop jointly with the parents of children participating in Title I services, a written parent and family engagement policy that describes how the school will carry out the parent and family engagement requirements set forth in The Every Student Succeeds Act (ESSA), section 1116(a)(2). ## Odyssey Online Learning will do the following:

  - Implement effective family engagement activities and involve families in school activities by inviting them to quarterly social outings provided to our student body.
  - Conduct an annual evaluation of the effectiveness of the policy in improving the academic quality of the school, including identifying barriers to greater participation by families and utilize the findings to design strategies to support successful family interactions and to revise engagement policies.
  - Provide assistance to parents in understanding topics such as the challenging State academic standards, State and local academic assessments, how to monitor their child's progress, and how to work with the school and teachers to improve the achievement of their children by utilizing a School Improvement Team, working with Success Coaches and Interventionists, and sending monthly video newsletters with updates.
  - Provide materials and training to help parents work with their children to improve their children's achievement by providing one on one assistance annually and as appropriate to foster parental involvement.
  - Educate teachers, personnel, and school leaders on the value and utility of contributions of parents, how to communicate and work with parents as equal partners and build ties between parents and the school by embedding it in bi-weekly staff meetings and quarterly professional development.
  - Coordinate and integrate parent involvement programs and activities with other Federal, State, and local programs, and conducts other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children by allowing opportunities for parent feedback, inquiries, and suggestions.
