- 3. Update from Executive Director Ashley Owings & Tracey Stuckey
 - Ashley Owings:

Discussed the Race to 40 Project:

- Discussed that the team met and goal that we had set to reach for academic performance needed to keep moving forward.
- Discussed that goal for 2023-2024 school year is 600 students
- Discussed graduation and testing
- Tracey Stuckey Congratulated everyone on the success of the Race to 40 Project and reiterated the that we need to keep that moving forward for Odyssey's academic scores.
 - -In January 2023 at our last board meeting Odyssey was told that they needed to become a full AEC school or get to 40 to keep running at current plan. Odyssey reached the goal and exceeded to end up with 50.72% by deadline.

Students' grades and scores are improving and they are succeeding at Odyssey.

 - In contract with Edmentum for another year
 - Edmentum hires the teachers and they are staffed by Edmentum
- 2024- 2025 school year Odyssey is planning on bringing all teachers back in house and under Odyssey. Odyssey currently has several inhouse teachers, counselors and staff for education.
- Discussed different platforms that Odyssey can use to enrich the learning experience
 - Enrich
 - Intervention Central
 - IXL
 - Easy CBM

Odyssey is currently utilizing a lot of these platforms now.

- Discussed ways to get students to want to come to class and participate.
 - Canvas, Blackboard, Google Classroom
 - Nearpod or Pear Deck
 - Have more interactive instruction
 - Break the learning up into small chunks
 - Clarity let the students know what is expected of them and the parents
 - Include the students in the learning process and make the classes fun to come online.
- Currently utilizing Blackboard with all inhouse teachers
 - Get parents involved with learning what Blackboard is and how they can get

engaged in their students' lives.

- within the 1st year of high school 35% of all students fail at least one class (this is for 9th graders)

- Required Orientation each year
- Weekly or monthly E newsletters or calls
- Have Regional Events that Parents and Students come to

 - Workshops that could help them both as parents and in their everyday lives.
 - Academic needs technology skills
 - Social/Emotional Needs both parents and students
 - Career Readiness (parents/students)
- Have Training classes that may interest and be of subject matters for parents.
- Yearly kickoff event in a central location
- Field Trips or tours of prospective careers and colleges around the state.
