<u>In-car Course Length:</u> The Virginia State Drivers Education program consists of Two Phases. The in-car phase consists of a minimum of seven periods of actual driving and seven periods of observation. Normally two periods of instruction are given during each session.

Scheduling: Each period of instruction is 50 minutes. In-car students are responsible for scheduling in-car instructions. We have found that scheduling your next lesson while in-car works best. Your starting date is _______.

<u>Make-Up:</u> If you miss any period of instruction there will be a make-up session any Monday in the condition that there is at least one other student needing make-up.

Methods of Payment: We accept Personal Checks, Cash, Venmo, Zelle and Cash App.

- Road Test Failure (3 Times) Re-Examination (7 Road Sessions): \$350

Behind the wheel and in-car tuition is paid in advance of instruction. There will be a <u>\$40</u> fee for any returned checks. The return checks fee doubles if the payment arrangements are not made in a week of notification.

<u>Refunds:</u> All refunds must be requested in writing. If instructions are discontinued for any reason, tuition fee will be calculated for the past sessions and the balance will be paid within 4 weeks.

<u>Lesson Cancellations:</u> Student must cancel/reschedule in-car lessons at least <u>24 hours</u> in advance or will be subject to a <u>\$40</u> fee. If for any reason the school decides to cancel a lesson, the student will be notified at the phone number listed below and the lesson will be rescheduled at a convenient time for both parties.

<u>Disclaimer:</u> Be it known that there is <u>NO</u> guarantee that students will pass the state license examination or that the student can secure license, or that the student will be guaranteed employment upon completion of the course.

Replacement of Completion Papers: There will be a \$40 fee for our time to replace any completion document.
