The farm includes 138.8 FSA cropland acres with an above county average CSR2 soil rating of 84.7. The primary soil types include top producing Ioam soils of Canisteo, Webster, Clarion and Nicollet.

The asking price for the farm is \$2,093,000.00.

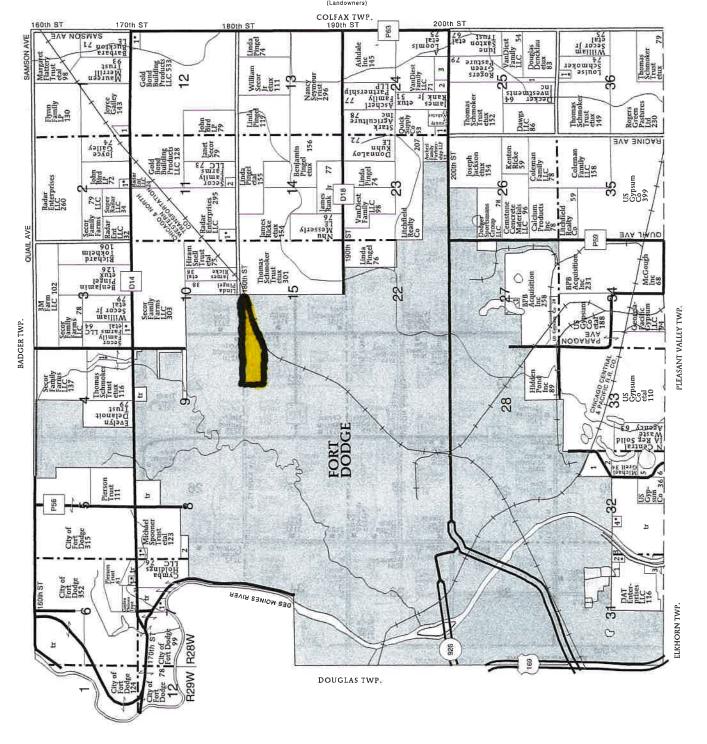

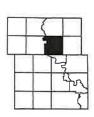

Aerial Map





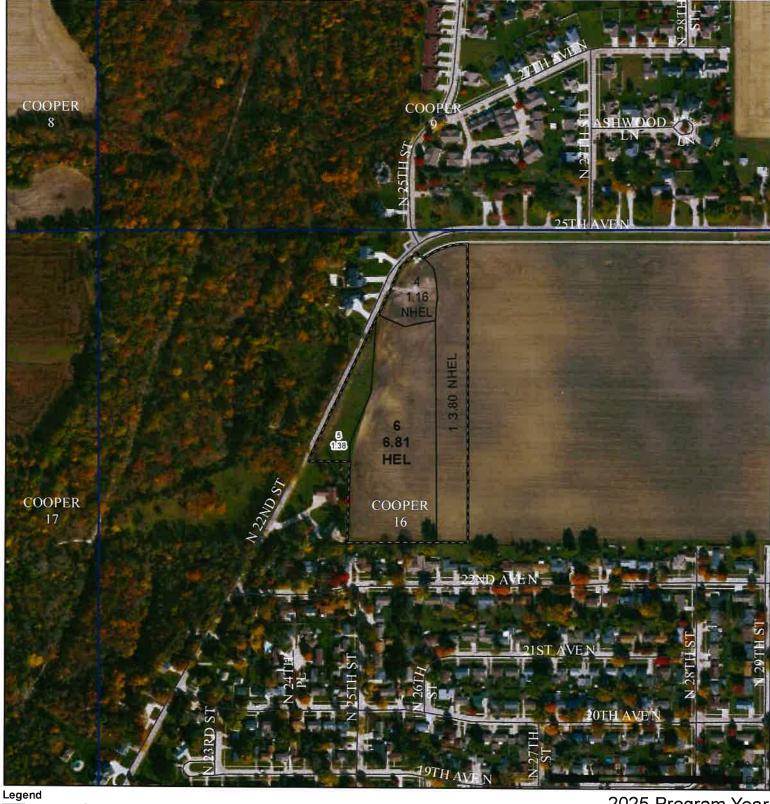
