Waiver, Release, Hold Harmless, and Indemnity Agreement

For value received, the receipt and sufficiency of which is hereby acknowledged, The Doggie Playhouse, Inc. ("Playhouse") and _____ ("customer") hereby agree as follows:

Playhouse is an Illinois corporation, incorporated for the purpose of providing canine daycare services. This agreement shall be construed and governed by the laws of the State of Illinois, and the parties submit and consent to the jurisdiction of the Circuit Court of Cook County, Illinois.

1. Customer understands that there are risks with the daily care of customer's Dog(s) and as the owner of Dog(s), customer agrees to be solely responsible for all acts and behaviors of the Dog(s) at any time during the term of this agreement, including any medical bills which may ensue from the behaviors other than for the exercise of gross negligence on the part of Playhouse, its agent, or employees, in the daily care and maintenance of the Dog(s) while in the custody of Playhouse whether on the premises or not.
2. That Playhouse will exercise ordinary and responsible care of all dogs under its care at all times, but that Playhouse shall not be under any obligation to guard against injuries which it has no reason to expect on account of the disposition of an individual dog.
3. That the customer is familiar with the disposition of their Dog(s) and is aware of any mischievous or vicious propensities of the Dog(s), to include a disposition by the Dog(s) to attack, bite, scratch, and otherwise injure or attempt to injure other dogs or people.
4. Playhouse shall not be liable and customer releases Playhouse, and its officers, employees, agents, and directors, from any injuries or damages to the Dog(s) arising out of or from the daily care and maintenance of the Dog(s) or that may accrue from any cause whatsoever in connection with the care and maintenance, including loss by fire, theft, running away, death or injury while under the care of Playhouse during the term of the Agreement, whether the Dog(s) be on the premises of Playhouse or not, except where any loss is caused by gross neglect or intentional act of Playhouse or its agents or employees.
5. Customer shall indemnify, protect, defend, and hold Playhouse, and its officer, employees, agents, and directors, harmless from and against any and all losses, damages, injuries, or claims that arise during Playhouse's performance under the Agreement or as a result of Playhouse performing the daily care and maintenance of Customer's Dog(s). This indemnification shall include, but not be limited to, any losses, damages, or claims resulting from physical injury to or death of the Dog(s), disease contracted by the Dog(s) and any injury or damage to third parties or third parties' property or dog(s) caused by the Dog(s). Customer shall assume all liability and defense of any suit, or other legal proceedings brought to enforce any losses, damages, injuries, claims, demands, expenses, and all other costs then resulting from and all judgments entered in any suit or legal proceedings.
6. The customer grants to Playhouse full power and authority to perform the Services, including, but not limited to performing all acts necessary to care for and feed the Dog(s). The Customer shall provide to Playhouse any and all materials and supplies necessary to

perform under this Agreement. The determination as to what materials and supplies are necessary shall be in the sole and exclusive discretion of Playhouse. The customer shall reimburse any expenditure by Playhouse for material or supplies to Playhouse immediately upon demand.

7. Customer may cancel this agreement by notice given no later than forty-eight (48) hours prior to the date such services are to be rendered. If, in the event Customer fails to give timely notice set forth herein, Customer agrees to pay Playhouse an amount equal to one half of the charge as agreed upon for liquidated damages.
8. Playhouse may cancel this agreement without prior notice at any time for any reason, including, but not limited to, aggression by the Dog(s) toward other dogs or to the employees or agents of Playhouse. The determination as to whether the Dog(s) is/are aggressive shall be made at Playhouse's sole and exclusive discretion. **PLAYHOUSE RETAINS THE EXCLUSIVE RIGHT TO REFUSE TO PROVIDE SERVICES FOR ANY DOG(S) AT ANY TIME, FOR ANY REASON.**
9. Any veterinary services rendered hereunder and any costs associated with taking the Dog(s) to the veterinarian, shall be the Customer's sole expense and any such costs paid therefore by Playhouse shall be reimbursed immediately to Playhouse by the Customer.
10. **THE CUSTOMER WARRANTS THAT THE DOG(S) IS/ARE NOT AGGRESSIVE AND HAS/HAVE NOT EXHIBITED ANY AGGRESSIVE BEHAVIOR.**
