3. REMOVE ALL PLUGS AND GIZZMOS.
4. REMOVE ANTI-FREEZE FROM UNDERGROUND PLUMBING LINES.
5. START UP FILTER SYSTEM ON MAIN DRAIN. (CUSTOMER TO FOLLOW STEP #1 BELOW)
6. ADD OPENING LIQUID SHOCK. (CHLORINE POOLS ONLY).
7. START UP HEATER, CHECK OPERATION THEN TURN OFF.
8. IF POOL/SPA EQUIPMENT FAILS TO OPERATE PROPERLY AT TIME OF OPENING, CUSTOMER WILL BE NOTIFIED. UPON AUTHORIZATION FROM CUSTOMER, MEIER'S WILL REPAIR AT STANDARD SERVICE RATE

(CUSTOMER TO HAVE ALL
EQUIPMENT AT POOL SIDE.)

CUSTOMER'S RESPONSIBILITIES AFTER OPENING

1. CUSTOMER IS TO FILL POOL WITH WATER TO NORMAL OPERATING LEVEL, THEN CUSTOMER HAS TO TURN ON SKIMMERS AFTER WATER IS HALF WAY UP IN SKIMMERS. CUSTOMER TO CLEAN OFF COVER - ALL DEBRIS AND WATER.
2. BEFORE ANY OTHER CHEMICALS ARE BOUGHT OR ADDED, PLEASE BRING ONE (1) QUART OF WATER INTO OUR STORE TO BE TESTED TWENTY FOUR (24) HOURS AFTER FILTRATION SYSTEM HAS BEEN OPERATING.
3. POOLS FOUND CLOUDY OR WITH VISIBLE ALGAE GROWTH MAY REQUIRE EXTENDED EQUIPMENT OPERATION AND ADDITIONAL TREATMENT BY CUSTOMER.
4. "REMINDER" CUSTOMER TO REPLACE NATURE 2 CARTRIDGE AFTER WATER IS BALANCED.

MEIER'S agrees to supply necessary materials, and perform all labor to open pool (as per contract). Customer does hereby agree to pay MEIER'S any additional material or labor costs, not included in this contract, but done at customer's request.

IF THE AMOUNTS TO BE PAID PURSUANT TO THE TERMS OF THIS CONTRACT ARE NOT PAID WITHIN 10 DAYS AFTER DUE DATE AS HEREIN BEFORE SPECIFIED FOR EACH SUCH PAYMENT. A DELINQUENCY CHARGE ON EACH SUCH INSTALLMENT IN DEFAULT OF 1-1/2% OF THE INSTALLMENT PER MONTH SHALL BE CHARGED AND THE CUSTOMER HEREBY AGREES TO PAY SUCH DELINQUENCY CHARGE IN ADDITION TO THE CONTRACT PRICE HEREIN SPECIFIED, IN ADDITION, THE CUSTOMER IS OBLIGATED TO PAY COSTS AND DISBURSEMENTS, INCLUDING REASONABLE ATTORNEY'S FEES, INCURRED BY MEIER'S IN LEGAL PROCEEDINGS TO COLLECT THE SUMS DUE PURSUANT TO THIS CONTRACT AFTER DEFAULT.

To secure payment hereof, the undersigned, jointly and severally, hereby irrevocably authorize any attorney of the Court of Record to appear for them, or any of them, in such Court, in term time or vacation, at any time after default in payment hereof, and confess judgement without process against them, or any one of them, in favor of MEIER'S, for such sum as may appear to be unpaid and owing thereon together with any delinquency charges, interest, costs and reasonable attorney's fees, and to waive and release all errors which may intervene in such proceeding and consent to immediate execution upon such judgement, hereby ratifying and confirming all that said attorney may do by virtue hereof. This contract has been executed and delivered at Fox Lake, Illinois, and shall be governed by the laws of the State of Illinois. If any provision of this contract shall be prohibited or invalid under applicable law, the remaining provisions shall not be invalidated. If this contract is signed by more than one person, their obligations hereunder shall be joint and several.
