DIRECTIONS FOR USE

Add Padlock PLUS ULTRA first to agitating tank. For use with herbicides (including desiccants, insecticides, and fungicides). Prior to use, read all directions chemical label directions, and directions on this label. Padlock PLUS ULTRA is not intended as a substitute for good agronomic practices, and sound application techniques must be used when spraying.

HANDLING AND STORAGE
