

#### **SET UP (SCREEN) CHARGE(S):**

New Design: \$25.00 per color, per design, per location, per order. Existing Design: \$20.00 per color, per design, per location, per order.

#### **LESS THAN MINIMUM:**

\$25.00 for orders less than 12 pieces.

#### **COMBINATION PRICING:**

A combination of many different styles is allowed in an order to reach the price breaks as listed in the catalogue or on the internet, as long as they feature the same logo/decoration and one common imprint location.

#### **NUMBERS:**

Pricing for silk-screening numbers is per digit, in one color and is as follows: 2", 4" and 8" digits are \$7.50 each digit.

#### **RUSH CHARGES:**

\$100.00 charge will be applied to all orders with a request to be produced/shipped in 3 business days or less from the date the sales order is writted. Artwork must be approved within 24hours. \$75.00 charge will be applied to all orders with a request to be produced/shipped in 5 business days from date sales order is written. Artwork must be approved within 48 hrs.

#### **SHIPPING & HANDLING:**

#### **COLOR CHANGES:**

In one order are \$20.00 per change, per location(s).

#### **PERSONALIZATION:**

Silk-screen names incurs a charge of \$7.00 for a left/right front & \$10.00 for a locker tag.
