How To Register

Full payment includes the Registration Fee and Tuition. To lock in the current Tuition rate for the 2025-2026 year, you must be registered and pay in full your first month. Classes are not held for students until full payment and all paperwork are returned to dancemaker.

*Dancemaker accepts payment by CASH, VENMO, and all major Credit / Debit Cards.

- 3 Make sure you sign and date WAIVER (one for each student)
- 4 Read, Sign + Date 'HOLD HARMLESS AGREEMENT' (one for each student)
- 5 Bring paperwork to the studio.

Recommended classes will be discussed with you during Registration. Class naming and numbering are based on our system and reflect each class in relation to other classes available on our current schedule.

If you are in Jaz 3, Jaz 4, or Jaz 5 you are required to take Ballet. PrePointe is available to Level 2 and up. Pointe requires at least one additional Ballet class plus Turns + Leaps. These guidelines are based upon a proven program, designed and developed after years of work and success with our students.

The following classes may be added to enhance your dance experience at Dancemaker.

MUSICAL THEATER WORKSHOP Voice and Dance (Ballet and/or Jazz) class is required. This class is available to all students ages 11 years + Up.

LYRICAL 1 Ages 10 years and up. Ballet and or Jazz required. 'Turns + Leaps' students have priority.

LYRICAL 2 Ages 12 years and up. Ballet and or Jazz required. 'Turns + Leaps' students have priority.

LYRICAL 3 (Teacher Referral) Ballet, Jazz, and 'Turns + Leaps' required.

TURNS & LEAPS recommended to Levels 3, 4, and 5. Required for Ballet 3, Ballet 4/5, and Pointe Classes.

HIP HOP 1 (ages 10 - 12yrs) and HIP HOP 2 (12 + Up) taking a Ballet and/or Jazz class.

HIP HOP 3 (Teacher Referral)

To add **PrePointe** to your schedule - speak to Bernadette and/or Geoffrey during Registration.
