

PMSI Spring Game Sweepstakes

SWEEPTAKES OFFICIAL RULES

1. **Eligibility:** The Sweepstakes is open only to legal residents of the United States, aged 18 or older. Employees of PMSI, Pest Management Services (“**Sponsor**”) are not eligible to enter.
2. **Entry Period:** The Entry Period begins and ends on April 12, 2025 (the “**Entry Period**”).
3. **How to Enter:** Visit <https://mypmsi.com/viriniatech> and complete the entry form during the Entry Period. Entries must be received by 2 pm April 12, 2025, to be eligible for the drawing. There is a limit of one (1) entry per person. By entering, you indicate your full agreement to these Official Rules and Sponsor’s decisions regarding the Sweepstakes, which are final and binding.
