School-Age Tuition Agreement

1. This tuition agreement is between KIDCO, Inc. and the undersigned.
2. Tuition is calculated on an annual basis. Payment is expected for sick days, suspensions, holidays, weather related closings, or any pandemic or serious health outbreak.
3. All accounts are **billed monthly**, regardless of how you elect to pay tuition.
4. Tuition is paid on the 1st of the month for monthly payers or the 1st and the 15th of the month for bi-monthly payers. Payments received after the 1st or the 15th will be assessed a 10% late fee.
5. ***Any account with an outstanding balance that exceeds the amount we have on deposit will receive a written notice and be subject to dismissal.***
6. A fee of \$20 will be charged for any payment returned from the bank unpaid. A replacement payment is due immediately, which should also include the 10% late fee.
7. **CLOSING TIME IS 6:00 PM SHARP.** Please leave yourself enough time to pick up your child and be able to leave the Center by 6:00 PM. Any child remaining on the premises past the 6:00 PM closing time will be considered a late pick up and subject to a late pick up fee. A fee of \$5.00 will be charged for each 5-minute interval (or portion thereof) after 6:00 PM.
8. This tuition agreement is void under the following conditions: **1).** A parent leaves the Center voluntarily. **2).** If a child is expelled from the program for disciplinary reasons. **3).** If a parent is discharged for non-payment of tuition.
9. KIDCO, Inc. reserves the right to dismiss a child for disciplinary reasons that we feel disrupt and/or undermine the daily running of the Center. If a child is expelled from the Center for disciplinary reasons, the parent forfeits any security deposit on account.
