The following is a contract between Noah's Pet Motel (Noah's Pet Care LLC) and the pet owner whose signature appears below

- Pets will receive reasonable care as seen fit by Noah's Pet Motel. Any cost incurred by said pet is the owner's responsibility.
- I will not leave my pet at Noah's Pet Motel permanently. If an animal is not claimed and boarding fees are not paid on or before the date set forth herein, it is understood and agreed that Noah's Pet Motel reserves the right to surrender pets left in our care no sooner than ten (10) days after written notice is sent to the above address.
- I understand that in the event of illness or emergency the staff will attempt to contact me or my emergency contact to discuss the problem and treatment options but may not be able to contact me immediately and is therefore authorized to initiate appropriate treatment until I can be reached. I agree to pay, in full, all charges for services rendered for and to my pet. I give Noah's Pet Motel permission to contact my vet to obtain health records and information about my pet.
- I understand that the facility is not responsible for loss or damage to personal items left with the pet or at the facility including but not limited to leashes, collars, toys, and bedding.
- I understand Noah's cannot guarantee the health of my pet and I understand and will not hold the kennel responsible for conditions that are unavoidable in boarding kennels and or play with other dogs, such as but not limited to canine cough (upper respiratory infections), cuts/scrapes, happy tail, and colitis. I understand all pets admitted to the kennel must be protected against communicable contagious diseases and must be free of internal and external parasites. Pets showing symptoms of contagious illness, illness not disclosed prior to intake, or internal/external parasites may not be admitted for services.
- If at any point it becomes unsafe for your pet to stay at Noah's Pet Motel, (ex: pet exhibits signs of aggression to humans, signs of contagious illness, or serious medical issue requiring care beyond the capabilities of our facility) the owner or an emergency contact must retrieve the pet within the time set forth by Noah's Pet Motel.
- While reasonable precaution is taken to ensure the safety and wellbeing of all pets, pets are boarded by us without liability on our part for loss or damage from disease, injury, escape, theft, fire, death, injury to persons, other pets or property by said pet or otherwise unavoidable causes. The client assumes all risks associated with unsupervised housing, including but not limited to interactions between pets being housed together, ingestion of bedding/gravel/toys, or injury.
- Owner agrees to abide by the prices, policies and procedures posted in the facility's lobby and on its website on check-in date. Noah's Pet Motel reserves the right to adjust said prices, policies and procedures at any time.
- There is a \$25 fee for any grooming appointments not cancelled with at least 24 hours notice. Additional costs will apply to pets being dropped off and picked up after business hours. A fee equal to one day of the boarding or daycare accommodation not cancelled will apply without at least 24 hours notice of cancellation.
- I understand that Noah's Pet Motel is not responsible for any fines distributed to the dog owner by the Pennsylvania dog warden for violating PA dog laws.
- Noah's may take photographs/videos of pets and may post or reproduce all photographs/videos taken (as well as pet(s) name) on or in, without limitation, the facility's website, social media sites or promotional materials without becoming liable to the owner for any royalties. Owner discharges the facility of and from all claims, demands, rights, and causes of action. If you wish Noah's keep your pet out of media, please initial here. _____.
- I understand that in the event my dog develops diarrhea (persistent) he/she will be fed Hill's digestive care or another bland diet at an additional charge unless declined. Initial here to opt out. _____.
- Pet owner certifies the accuracy of all information conveyed in this document and agrees to the statements above. This agreement will remain valid and in force as long as and whenever any/all of my pets are in the care of Noah's Pet Motel.
