Nominations need to be sent by mail to P.O. Box 163, East Troy, WI 53120. Nominations must be postmarked by April 1, 2024.

Terms & Conditions:

"Military On Top" is not a contest or lottery.

One deserving nominee in 2024 will be selected to receive 1 new roof solely gratis at the discretion of James R. Taylor and Sons, Inc.

Nomination Rules for "Military on Top":

- 1. A nominee must be a legal resident of the State of Wisconsin and Walworth County who is 18 years of age or older, who is currently serving or has previously served in the United States military (Army, Navy, Air Force, Marines, National Guard, Reserves). Proof of a current military ID or a DD form 214 must be submitted. Entries must be submitted to James R. Taylor and Sons, Inc. at 2115 Division Street, East Troy, WI 53120. James R Taylor and Sons, Inc. (hereinafter JRT & Sons, Inc.) reserves the right to examine identification and may reasonably choose to accept or deny awarding the roof based on the identification presented.
- 2. Nominee may only receive one complete roof system installed according to local and manufacturer specifications. JRT & Sons, Inc. determine the asphalt shingle and manufacturer. Recipient determines or chooses color.
- 3. Nominee must own home and be in good standing on their monthly mortgage payments.
- 4.
